Drops in the Ocean: Sea Saviors in Shepherds' Clothing

Earlier this year, my environmental science class studied a documentary about the negative effects of the modern-day maritime fishing industry. I discovered myself to be quite interested in the subject. Thus, when I went to select my history fair topic, my mind jumped to Sea Shepherd, an organization in the documentary celebrated for its rare success in disrupting harmful activities such as illegal fishing and exploitation. Sea Shepherd relates to the theme because due to Sea Shepherd, the world is in a 21st-century turning point away from marine abuse, corruption, and irresponsibility, instead heading toward protected oceans capable of sustaining the Earth for years to come.

I conducted my research by first reviewing the documentary from which I had drawn my inspiration. I then proceeded to delve into Sea Shepherd's website, where I studied data collected by the organization regarding their impact and various operations. From there, I began researching the context of Sea Shepherd, including the problems it combats and the importance of their mission. I also purchased a book full of research on the reduction of whale populations. Overall, I reached out to around forty individuals, including professors, Sea Shepherd recruits, and environmentalists, in hopes of attaining interviews. The eleven interviews I received contributed greatly to my project, providing a credible base for my claims.

I created my project using NHD's website builder. To incorporate advanced visual elements, I invested my time into making custom designs in the application Keynote. I then planned a common color scheme and formatting technique that I would use uniformly across the website for enhanced visual appeal and complementary organization. From there, I was able to begin entering more specific information, including quotes, pictures, and other elements. iMovie and Piccollage proved to be instrumental in developing a unique nature to my website with their

options for custom animations. Overall, I strove to create an interactive experience with a variety of creative mediums.

My historical argument is that marine environments are currently being compromised by irresponsible, profit-seeking corporations. These entities engage in harmful behaviors such as overfishing, illegal fishing, generating bycatch, abandoning fishing gear, and fish farming. The members of Sea Shepherd have taken on a prominent role in marine conservation through direct action campaigns, physically traversing ocean waters and risking their lives in the process. Sea Shepherd also makes use of outreach programs to spread awareness and garner public support.

Sea Shepherd is significant due to its application in modern-day issues and its implications for the future. Oceans are vital to the health of the planet and thus to the future of the human population. For instance, marine life plays a massive role in compensating for extensive carbon emissions by acting as a carbon sink. However, the ongoing exploitation of aquatic species and the lack of environmental awareness in an ever-expanding commercial culture has threatened the ocean in recent decades. Sea Shepherd has been the leading organization combating this threat, making a real impact that can be seen through evidential data.
